<u>If</u> a major disaster strikes our area, our citizens may have to rely on each other for immediate lifesaving and life sustaining assistance.

<u>If</u> a child or person is lost in our area CERT volunteers will be requested to assist in the search.

EastTex Regional CERT Program supports First Responders in Rockwall, Collin, Kaufman, and Hunt Counties in north Texas.

Our CERT program teaches emergency preparedness and basic disaster response techniques that will prepare citizen volunteers to take an active role in providing critical support for family and neighbors prior to the arrival of professional first responders during emergencies. Our CERT Team assist Emergency Management, Fire and Police in doing basic Search and Rescue, medical triage, helicopter landing zone operations, traffic and crowd management, damage assessment, accounting for residents, securing routes into and out of neighborhoods, missing persons search, traffic control and special events support.

EastTex CERT is also aligned with the Northeast Texas Child Abduction Response Team (CART) and responds to requests from missing children, juveniles and adults deemed at risk in North Texas. www.netxcart.org

The next open training session will be taught on **March 18rd and 25th in Ables Springs, Texas** at the Volunteer Fire Station. Training is from 8:30 am to 5 pm (two consecutive Saturdays). The course will be taught by certified FEMA instructors and have hands-on indoor/outdoor activities.

Release of Liability Form (ETC201) is releases the city, county and all affiliates from any personal liability as this CERT program is entirely voluntary and C. General Information.
